POSITIVE TRADING PERFORMANCE FOR FY19 – WITH RECORD PBT OF \$32.5 MILLION

Alliance Aviation Services Limited ("Alliance") pursues and measures excellence across three main areas:

- 1. Safety;
- 2. Operational Performance (On-Time Performance); and
- 3. Profitability.

FY19 has seen a continuation of Alliance's safe and reliable operations along with industry leading on time performance of 95%.

Alliance is likely to achieve a Profit Before Tax for the year ending 30 June 2019 in excess of \$32.5 million, which will be the best profit performance in the company's 17 year history.

It is in excess of analysts' consensus and 25% above the Profit Before Tax for FY18.

Mr Lee Schofield, Alliance's Chief Executive Officer, said, "The significant growth of the company is the result of our continued safety focus and market leading on-time performance. We jealously guard these attributes and support our team to deliver improvements for our customers."

Mr Schofield, further said, "Our diversification strategy continues to be successful. Pleasingly this year we have again delivered a solid year on year profitability increase. We now have four different flying categories (contract – mining and tourism, charter, wet lease and scheduled airline services) and operate regularly to over 50 destinations. Our current fleet of 38 aircraft operate across all categories of flying. An additional aircraft will join the fleet this week and a further aircraft during July."

By the end of this calendar year the operating fleet at a minimum will be:
